- FINANCIAL EXPLOITATION / EXTORTION
- > USE OF FORCE

- BANNED FROM THE HOSTEL
- HIS/HER SCHOLARSHIP CAN BE WITHDRAWN

- PROSECUTED FOR CRIMINAL ACTION.
